Procedure for Election of New Members

New members are elected by ballot of the Clubs' General Management Committee which usually meets once a month.

Every candidate for election must be **proposed** and **seconded**; both proposer and seconder must themselves be members of at least two years standing.

Nominations are placed before the Committee and, if approved, 'posted' on the Club noticeboard until the next meeting of the committee one month later.

At the second meeting, committee members vote on the nomination and if approved the nominee is elected.

Nominees may be called for interview by Officers of the Club.

Applicants should enclose a cheque for their **first Annual Subscription** (made payable to 'Conway Yacht Club Ltd.') when submitting their application

Proposers and seconders are asked to ensure that their nominee has correctly completed the Membership Nomination Form and that a *cheque is enclosed with the form when it is submitted*.

On election a new member is notified in writing by the Membership Secretary; payment of the first subscription is deemed to be acknowledgement of the member's acceptance of the Articles and the Bye-Laws currently in force.

Annual subscriptions are set by the General Committee and cover membership for the Club Year which runs from 1st. July to 30th. June.

ALL annual subscriptions become due on **1st. July** each year.
